Playground Equipment Review

A. van Moessner to send the proposed playground equipment documents and grant information to the Commission members via email for their review and discussion for the upcoming December meeting. Recipient of the grant is expected to be announced prior to the December meeting.

Currently the Recreation Commission has \$20,000 reserved for playground equipment. If the grant is received, another \$40,000 will be available with a matching contribution required of \$40,000 via fundraising.

Alternate Member for Recreation Commission

Robert Fitzsimmons, Kinderhook Village Attorney, has provided Mark Browne, Village Trustee, with the language needed in order for the Village Committees and Commissions to select an alternate member for appointment by the Village Board. Discussion of the language and its approval will take place at this week's Village Board Meeting. D. Weir to update the Recreation Commission at next month's meeting.

New Business:

Candlelight Night - Saturday, December 3rd - 6:00 pm - 8:30 pm

The KBPA (Kinderhook Business Professional Association) requested assistance from the Recreation Commission with set-up for Candlelight Night. Since the KBPA has a full list of activities planned, discussion was had regarding assisting the KBPA for this event.

D. Weir announced Richard "Rich" Phillips, former Village Trustee, would like to donate a tree from his yard, approximately 10 ft in height to be placed in the Village bandstand. D. Weir suggested the Recreation Commission members decorate the tree with lights and incorporate a "tree lighting ceremony" during Candlelight Night. This suggestion was well received. The intention is to have the lighting take place at 7 pm and possibly D. Dellehunt (if he is available) to MC the ceremony. If D. Dellehunt is not available, it was suggested Mayor Leiser or a Village Trustee could MC this event.

If interested in decorating the tree with lights, please meet at the bandstand on Wednesday, December 1st at noon. The DPW will assist with tree preparation and bandstand placement.

Budget Update

D. Weir updated the Commission on budget funds remaining for event planning - \$217 remains, which does not include the expenses incurred for Halloween. As a result, funds from another budget line in the Recreation Commission's budget will need to be reduced to cover Halloween and upcoming events.

<u>Library - Kite Flying Day - April, day TBD</u>

The possibility of participating with the Library for Kite Flying Day was discussed. Readings, kite assembly, and flying contest are planned for 3 Saturdays in April. Although the Commission is interested, this is a busy time of year for the Recreation Commission as they prepare the budget, Spring Egg Hunt, and plan for the Summer Camp Program along with the hiring process of Summer Camp staff.
