The Village Board entered the budget meeting with a total proposed budget of \$1,476,560.00. The total assessed value of the village of \$164,132,186.00. The proposed amount to be raised by taxes of \$361,244.00 with a tax rate of \$2.20093 per thousand of assessed value.
