## Albany Ave

Trustee Browne reported when the contractor was removing the trees for the Albany Ave Bicycle and Pedestrian Project there was a small amount of damage done to the decorative trim work at 28 Albany Ave. Trustee Browne motioned to hire a contractor to fix the damage to the property owners satisfaction and charge the contractor; seconded by Trustee Patterson, all voted "aye".

## **Budget**

The Village Board entered the budget meeting with a total proposed budget of \$1,649,003.21. The total assessed value of the village of \$167,471,916.00. The proposed amount to be raised by taxes of \$443,795.21 with a proposed tax rate increase entering the meeting is 13.56%.

The Village Board reviewed the tentative budget line item by line item in the General Fund, Water Fund and expenditures starting on pg. 8 where they ended at the March 21<sup>st</sup> meeting. Each member of the board stated what they were proposing in the tentative budget.
