# **Community/Business Outreach**

- 1. Continued discussions and support about village issues with The Kinderhook Knitting Mill.
- 2. Continued consultations with Kinderhook Bottle Shop re: data collection on village and surrounding areas for NYSLA application.
- 3. Kept business owners apprised of special board meetings.
- Received news from New York State Museum/Daria Merwin that Persons of Color Cemetery ground-penetrating study has been completed but a report not written. Awaiting written report.
